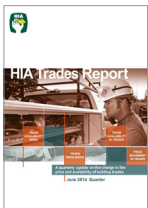

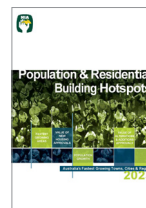

HIA Tailored Forecasts: New Dwelling by Composition and Regional New Home Building Projections

Dwelling composition forecasts:

- detached houses
- semi-detached, row or terrace house, townhouse or duplex with one storey
- semi-detached, row or terrace house, townhouse or duplex with two or more storeys
- flat, unit or apartment in a building of one or two storeys
- flat, unit or apartment in a building of three storeys
- flat, unit or apartment in a building of four or more storeys
- dwellings excluding new residential (typically called conversions).

Regional new home building projections:

HIA's Regional New Home Building Projections are prepared quarterly and show the expected level of new home commencements in all regional markets across Australia as well as providing distinct forecasts for detached and attached building markets.

The projections are particularly useful for any business operating in geographic markets where local conditions tend to differ from the more generalised state level conditions. The projections give an indication of the size of local markets, provide a point of reference for businesses estimating market share, enable benchmarking of business performance, and provide an excellent basis for businesses planning for the future. The projections are provided with a five year outlook and include historical data dating back ten years.

Regional projections go down to the SA3 level and are provided with a five year projection horizon presented in annualised terms (both calendar year and fiscal year).
